

## Membership Application

Membership in The Neon Group is broken down into four following divisions. Membership is extended to persons involved in or associated with the neon lighting industry. The firm or other party of interest applying for membership shall be classified in the division which is most appropriate to its principal type of business operation as determined by the board of directors. Membership divisions are:

### **Executive Membership (Annual Dues \$2,500)\***

Executive members are product manufacturers, distributors, neon wholesalers and sign companies whose primary business relies heavily on the neon lighting industry. These members are the main financial contributors as well as the controlling body of the organization. Executive members have full voting privileges, may serve as an officer or director on the board of directors, may use The Neon Group logo, will be recognized on the website and have full Knowledge Center access.

### **Corporate Membership (Annual Dues \$1,250)\***

Corporate members are product manufacturers, distributors and sign companies whose business is related to the neon lighting industry but whose reliance on the industry is not substantial. Neon wholesalers may join the Association as Corporate members. Corporate members have full voting privileges but may not serve as an officer or director on the board of directors. Corporate members may use The Neon Group logo, will be recognized on the website and have full Knowledge Center access.

### **Associate Membership (Annual Dues \$250)\***

Associate members are product manufacturers, distributors and sign companies who have an interest in the purpose and objectives of the Association, but whose primary business is not related to the neon lighting industry. Neon wholesalers may join the Association as Associate members. Associate members may use The Neon Group logo, will be recognized on the website and have full Knowledge Center access. Associate members will not have voting privileges, nor will they be eligible to serve on the board of directors.

### **Affiliate Membership (Annual Dues \$250)\***

Affiliate members are firms or individuals whose business is other than that of manufacturer, distributor, wholesaler or sign company but has an interest in supporting the objectives and purpose of the Association. The benefit of membership in the Affiliate membership division will be limited to full Knowledge Center access.
